Request for Expression of Interest for short listing of NGOs/CBOs for providing services for Targeted Interventions (TI) in Arunachal Pradesh under Arunachal Pradesh State AIDS Control Society, DHS, Naharlagun

1. This notice follows the General Procurement Notice (GPN) published in UNDB on 6th May, 2012.
2. The Government of India has applied for financing from the International Development Association (IDA) towards the cost of the National HIV/AIDS Control Project and it is intended that a part of the proceeds of this financing will be applied to eligible payments under the contract for which this invitation is being issued. The Project is an intervention with a goal of reducing the burden of HIV/AIDS cases in the country. The components of the project are prevention, care and support and treatment, programme management and strategic information management with one of its sub-components being targeted interventions for high risk groups, as well as utilizing civil society organizations for providing access of vulnerable populations to various HIV/AIDS interventions.
3. **Arunachal Pradesh State AIDS Control Society, Naharlagun** now invites applications from interested civil society organizations (NGOs/CBOs) from **Arunachal Pradesh** for providing services to implement HIV/AIDS Targeted Interventions (TIs) with highly vulnerable population groups i.e. High Risk Groups (Female Sex Workers (FSW), Men-who-have-sex-with-men(MSM), Transgendered Population (TG), Injecting Drug Users (IDUs) and Female Injecting Drug Users. The TI is expected to provide at least the common core services to all HRGs such as, at a minimum: peer education, condom promotion, referral for STIs, testing, linkages to treatment and care and support, and, in the case of IDUs, needle syringe exchange, Oral Substitution Therapy and referral ART or Link ART (for HRG PLHIV) and motivate them for De-addiction and Rehabilitation.
